Infringement with the use

If a client does not apply the trademark of agroVet GmbH according to the requirements included in this terms of use and the general terms and conditions, agroVet will send a written warning asking for the termination of the non-proper use of the trademark, including the corrections expected. In case of illegal use of the trademark, removal of the trademark will be expected.

Depending on the severity of the infringement, we can report the case to the competent government office.

If the client still displays some of the trademark illegally or not according to the requirements following agroVet's written warning, further steps will be taken, which may entail legal consequences.

In case of illegal use of the trademark of agroVet GmbH, unless parties come to a mutual agreement, the client is obliged to pay a fine for penalty in the amount of 10% of their income from the incorrectly labelled products, but a minimum of € 1000.- This penalty does not apply for the reduction of the penalties included other legal regulations.

Besides the above ones agroVet GmbH is entitled to terminate the contract is case of breach of the inspection contract.
